Heartland CU Signs 7 Yr Agreement for DP Services

Grand Rapids, Michigan –January 13th, 2010

CU*Answers, the West Michigan CUSO known for providing its enterprise core data processing system, CU*BASE, has recently announced that Heartland Credit Union (\$187M) of Springfield, IL, has signed a 7 year Agreement for data processing services. Heartland Credit Union has been serving the Springfield area since 1946, and now provides services to over 27,000 members from four (4) branch locations.

According to Ed Gvazdinskas, President/CEO of Heartland, the decision to upgrade to CU*BASE was approved by the Board of Directors in October, after more than two years of studying, reviewing and analyzing several different data processing vendors.
